ENTRY FORM

RULES & REGULATIONS

1. Participating vehicles shall be motorized and travel on 4 wheels (excluding lorries and buses) having road tax and insurance valid as at the day of the Hunt.
2. Each team shall consist of a driver and navigator, with an option of no more than two (2) additional passengers.
3. The Driver and navigator in each team must possess driving licenses valid as at the day of the Hunt.
4. All team members must sign the Declaration and submit it together with the Entry Form. The Declaration must be signed by parents / guardians on behalf of team members who are minors. The Driver and Navigator shall obtain the consent of the parents / guardians of all team members who are minors and the Organizer shall not be required to enquire if such consent has been obtained or not.
5. Entry Form is to be submitted in accordance with the instructions given in the information. Sheet issued in connection with this Hunt.
6. Proof of posting of Entry Form is not proof of receipt thereof.
7. All payment made are **NON-REFUNDABLE**.
8. Any changes to Entry Form after submissions are at the discretion of the Organizer. No changes will be accepted or permitted after Briefing day.
9. At least one (1) team member from each team must attend the Registration and Briefing and he/she/they shall be responsible for disseminating all information provided at the Briefing to all other team members.
10. All participants will be lodged on a twin-sharing basis. Additional rooms can be booked through MAH Secretariat.
11. Competition numbers and various car stickers provided by the Organizer shall be placed on participating vehicles as directed by the Organizer and must remain on the vehicles throughout the Hunt. No other form of advertising other than those provided by the Organizer shall be permitted. Participants are required to comply with the dress code for the Event as determined by the organizer.
12. Starting order for the Hunt shall be as determined by the Organizer.
13. All treasures submitted in the Hunt shall belong to the Organizer and no team or member thereof shall have any claim thereto.
14. The team that scores the highest number of points in the Hunt less penalty points incurred will be declared the winner and all subsequent positions will be determined on the same basis. Tiebreakers in the event of a tie shall be announced to the participants at the Briefing.
15. The Organizer reserves the right without assigning any reason therefore to:-
 - a) Abandon, cancel or postpone the event as deemed necessary;
 - b) Reject any Entry whether before or after the acceptance thereof;
 - c) Bar or exclude any one or more members from any team;
 - d) Disqualify and / or impose penalty points on any team found to have been guilty of
 - i. The breach of these Rules and Regulations and road traffic rules
 - ii. Collaboration or cheating in any manner
 - iii. Providing a false Declaration and
 - iv. Failing to complete the Hunt within stipulated time.
16. These Rules and Regulation may be added to or amended at the discretion of the Organizer. These Rules, all additions and amendments thereto, and the interpretation thereof and the decision of the Organizer in all matters concerning the Event shall be final and binding on all participants.
